

## Privacy Declaration Jayra

### Introductory provisions

This page contains the privacy declaration of the Person Responsible. You are advised to read this privacy declaration carefully. The Person Responsible has its registered office in Rotterdam, is entered in the commercial register of the Chamber of Commerce under number 72940891 and bears the name Jayra. The Person Responsible can be contacted by e-mail at [contact@jayra.nl](mailto:contact@jayra.nl) or by telephone on +31 (0)6 151 64285. This privacy declaration explains how the Person Responsible handles the processing of personal data, including what personal data or categories of personal data are being collected and for what purpose the personal data are being used. The Person Responsible also states the legal ground upon which the processing of the personal data is based.

Our processing of personal data falls within the statutory exemption regulations, which means that the processing has not been registered with the Dutch Data Protection Authority (Dutch DPA).

The Person Responsible reserves the right to make amendments to this privacy declaration. The current privacy declaration was last updated on 15 may 2018

### Types, purposes, legal grounds and period for processing personal data

Personal data are first processed when you enter into an agreement with us. Personal data are used for enrolling in the gym and to keep customers up to date with new information. The enrolment form states what data must be entered. These are: your gender, your first name and surname, your date of birth, your e-mail address, your telephone number, your address, your IBAN number, your postcode and the town/city in which you live. Your e-mail address is necessary to keep you up to date with new information, but will also be used to keep you up to date with products or services that may be of interest to you in the future, and we require your IBAN number to collect lesson fees and annual contributions, for example.

These personal data will be stored during the term of the agreement. Once the agreement (the sports subscription) has terminated, your personal data will be deleted from our systems.

Your data is processed based on the following legal grounds: your consent and the necessity to execute the agreement. If you do not wish to enter personal data, it will not be possible to create an agreement, or therefore a sports subscription.

### Cookies

The Person Responsible uses cookies on its website. What are cookies? A cookie is a small piece of data that a website stores on your computer. Each time you visit the website of the Person Responsible, it gathers basic technical information such as the website you used to access this website. This privacy declaration applies to cookies and similar technology. This website may use cookies to provide visitors with tailored information, to gather information, and to monitor visitors when visiting the website. This helps the Person Responsible to deliver a good user experience.

The following legal ground forms the basis of cookie usage: the legitimate interest. The legitimate interest of the Person Responsible is to improve the website.

### Transfer to processors and third parties

Personal data are processed by companies that have been employed by the Person Responsible to execute the agreement. The law refers to these companies as 'processors', and this may include the company that hosts our website, or a parcel service provider employed by us, for example. The processors operate under the responsibility of the Person Responsible.

Personal data shall also be shared with third parties if the Person Responsible is legally obliged to pass on personal data to competent authorities.

### Security

The Person Responsible has taken appropriate technical and organisational measures to safeguard your personal data against loss or unlawful processing. The website has an SSL certificate, which means that the data can be sent via a secure connection.

### Your privacy rights

You have the right to view, rectify, delete or limit the processing of your personal data in accordance with the provisions in the General Data Protection Regulation (GDPR). If you create an account on our website, you may view and amend the data you have provided, yourself.
